I Mary White of the County of Henrico and the Commonwealth of Virginia being weak of body but of sound mind and memory do make, ordain publish and declare this and no other to be my last will and testament in manner and form following that is to say. First, I desire after my funeral expenses are discharged that all my just debts may be paid especially in the nature of the care(?) may(?)_____ by my executor herein after nominated. Secondly, I give and bequeath unto my children Sarah Talley, Elizabeth Smith, Mary New, Robert White, Nathaniel White, and Lucy White the land which I bought of Mr. Turpin which adjoins the lands which I now reside to be sold and the money to be equally divided shared(?)among them or their heirs & assigns forever.

Thirdly, I give and bequeath unto Mary New a side saddle and all my wearing apparel, the saddle to be purchased out of my estate to her and her heirs forever.

Fourthly, I give and bequeath unto my daughter Lucy White one negro woman named Dianna and one negro man named Tom, all my stock of horses, cattle, hogs, and all my household and kitchen furniture with all the money and other property of every description of which I may die possessed of to her, her heirs, & assigns forever. If however my said daughter Lucy White shall depart this life before she has a lawful heir of her body then and in that event I give and bequeath all the estate to which she would be entitled if she has a lawful heir of her body to be equally divided among the remainder of my children who may survive her to them their heirs & assigns forever.

Lastly, I constitute nominate and appoint my son in law William Smith, John (Price?)Rice Sr., and Isham Goddin executors of this my last will and testament. In witness whereof I have subscribed this my last will and testament with my own hand on this 21st day of March in the year of the Lord one thousand eight hundred & four in the presence of witnesses who subscribed in my presence and in the presence of each other. "In the name of God, amen. I, William Smith of the county of Cumberland and state of Kentucky, being of sound mind and memory, but advanced in age and taking into consideration the uncertainty of life and certainty of death, and wishing to make a disposition of my worldly goods and concerns before I depart this life, do make, constitute, ordain, and publish this writing to be my Last Will and Testament in manner and form following, hereby revoking and disannulling all other wills and testaments by me heretofore made.

First, I give unto my beloved wife, Elizabeth, the tracts of land whereon I now live for and during her natural life and at her death to pass as I may hereinafter direct; also the following negroes, to wit: old Ben, old Julius, little Caesar; Phill; Simon Peter; Jack; Eliza; and her increase and ______ also all of my household and kitchen furniture; stock of every description, except such as may be herein after otherwise disposed of; all of my farming utensils; all of my shop tools of every description; all of my books of every kind and all of my money if any should be left in my house; all

bonds, notes or outstanding debts after paying all of my just debts and funeral expenses, to hold, occupy, and enjoy in any way she may choose for her maintenance for and during her natural life and with full power to dispose of all said property except the land and such other reserves as are hereinafter made by her last will and testament to all or any of my children or grandchildren as she may elect or choose. It is however, my will that old Ben, old Julius, and Phill shall live with whichever of my children they may choose after the death of my wife, should they survive her. Should my wife leave no will, it is then my will that what I have left her may be divided among my grandchildren then living; that is to say, the children of Susan M. White as one legatee; the children of Polly H. Gaines as one legatee; Nathaniel Smith's three youngest children as one legatee; Elizabeth Clark's two daughters as one legatee; to take that portion to which their parents would be entitled to were they all living and a division took place amongst them.

Secondly, I give and bequeath unto my grandchildren Harriet Smith, Francis Smith, and Elizabeth Smith the following tracts of land lying adjoining together below where I now live on Cumberland River, one containing two hundred acres called the Galloway tract, and one containing one hundred and fifty acres military land; also one other tract I purchased of Nathan Thurman where Daniel Wooldridge did live, containing seventy-five; the three tracts making in all four hundred and twenty-five acres and should I purchase the land where Havs Murphy now lives, it is my will that it be added to the above four hundred and 25 acres, thereby making the quantity of 500 acres. Given by me to said grandchildren Harriett, Frances, and Elizabeth Smith, but should I not purchase the same it is my will that three hundred and fifty dollars be taken out of any money that may be due or in hands to my estate, that my executors hereafter named may purchase said Murphy tract for the purpose aforesaid of being added to the tracts of land as above, making the said quantity of 500 acres to pass by this will to my said grandchildren above named: Harriett Smith; Frances Smith; and Betsy Smith; to them and their heirs forever; but should said Murphy tract not be purchased either by myself (or) my executors, the above named grandchildren last mentioned are to be entitled to the said sum of \$350. I also give and bequeath to the said Harriett Smith, Frances Smith, and Elizabeth Smith the following negroes: Fanny and her three youngest children Andrew, Jim, and Mary, and her increase: to them and their heirs forever, and as I had given to my son Nathaniel Smith in his lifetime, two negro men Olly and Davy, and his widow being entitled to a life estate in said negroes Olly and Davy, I purchased it for the benefit of my said three grandchildren Harriett, Frances, and Elizabeth Smith: it is therefore my will and desire and they are hereby vested with all the interest to which I am entitled in and to the said negroes Olly and Davy by my aforesaid purchase or being intended by me as fully for the benefit of said three grandchildren last above mentioned.

But should either of said three last mentioned grandchildren depart this life without lawful issue of their body, it is my will that the survivors enjoy the benefit of the above bequest and what I may hereafter bequeath to them the said three mentioned grandchildren.

Thirdly, I give and bequeath unto my daughter Susanna M. White and Barrett White her husband all my tracts of land lying on the south side of Cumberland River that I purchased of Robert Alveye and Hezekiah Ellington containing five hundred and twenty two or three to be occupied and enjoyed by them during their natural lives and at their death to go to the children of said Barrett White and Susanna M. White, his wife, and their heirs forever.

Also, I give and bequeath unto the said Barrett White and Susanna his wife the following negroes, to wit: Lewis and Nelly and all the increase that said Nelly now has or may hereafter have to them and their heirs forever. Having loaned to Barrett White the sum of \$546, it is my will and desire that he be acquitted and discharged from any claim for or an account of said loaned money but that the same be considered as given to him by me and taken into consideration in the division of my property in this will as so much received by him in way of advancement.

Fourthly, I give and bequeath unto my son-in-law James Clark one negro man named Frank. To him and his heirs forever, I also bequeath to him the use and profit of the farm whereon I now live, containing five hundred and fifty-five acres for and during his natural life from and after the death of my wife and after the death of said Clark, then said tract of land with its appurtenances to vest in fee simple in my two grandchildren Nancy Farris Clark and Elizabeth Susan Smith Clark, daughters of _____ James Clark and Elizabeth G. Clark, deceased, to them my two last mentioned

grandchildren and their heirs forever. I also give and bequeath unto my granddaughter Nancy Farris Clark one negro girl named Lucy and her increase after the decease of my wife, to her and her heirs forever. I also give unto Elizabeth Susan Smith Clark one negro girl named Sarah and her increase after the death of wife; to her and her heirs forever. I also lend my negro woman Aggy and her increase she now has and may hereafter have to James Clark during his life from and after the decease of my wife and at his death, I will and bequeath them to pass to his daughters before named, Nancy Farris Clark and Elizabeth Susan Smith Clark, to them and their heirs forever. But should said Charles William Smith die before arriving to the age (of) 21 years or without lawful issue of his body, then and in either of those events, said property, land, slaves, and money bequeathed to him shall revert back to my estate and be considered part thereof and be equally divided and distributed according to law among my heirs, children and grandchildren herein named.

Seventhly, I give and bequeath unto my grandson, William White, one negro boy named Reubin, to him, said William White, (and) his heirs forever. This devisee is made by me in compliance and wish of my daughter Nancy Smith, deceased, to whom I intended to give said negro boy and had so made known to her, who in her last illness requested him to be given to my said grandson, William White, which to her I declared I would do, and in every respect comply with her wish in relation to the property which had been set apart for him.

Eighthly, I will and bequeath unto my wife all the remainder of the property of whatever kind the same may not be disposed of in this my last will and testament, to use and enjoy and dispose of as she may think fit during her natural life, and at her death to be equally divided among my children and grandchildren according to law regulating distributin of estates.

Lastly, it is my will that all the furniture that my children took with them when they married and left me, they shall keep as their own and return none, and finally, should any part of this will not to be understood clearly, (here some words appear to be cut off), circuit court to appoint two men to make such decision which shall be binding on all parties.

Clinton Eye, Mar 28 1891 - Death has again called away one of Henry county's most highly respected citizens, Richard F. Gaines, who breathed his last Saturday night after a short illness at his home west of Clinton. In 1836, he was born in Cumberland county, Ky. and in 1860 came to Henry county. He was married twice, the first wife being a Stone, by whom they had one son, now 22. His second wife was Miss Dopha Merritt, daughter of Judge M. B. Merritt and they had a daughter, now 13. Deceased was an extensive farmer and stock raiser. Remains buried at Stone's Chapel. (from Find-a-grave)

The following is from bio of son, Charles William Gaines Sr, as published in 1919 History of Henry Co., by Uel W. Lamkin:

..."He was born in Henry County January 16, 1864 a son of Richard F. and Margaret (Stone) Gaines. The father, a native of Cumberland County, Kentucky, was born in 1839, while the mother's birth occurred in Henry County, Missouri, in 1841. She was a daughter of Judge John Stone, one of the antebellum pioneers, a member of the famous Stone family, who removed to Henry County in 1839 from North Carolina. The Stone family were very prominent in the early history of Henry County. In early life Richard F. Gaines became a farmer and stock dealer. About 1854 he removed to Missouri, settling in Saline County, and in 1860 came to Henry County, where the grandfather of our subject purchased the farm which was owned by Charles W. Gaines. Richard F. Gaines was largely reared in this State and became an extensive land owner and stock dealer. His father had been a large slave owner in the South. After the war Richard F. Gaines took charge of the estate and continued thereon until his death in 1891. He dealt extensively in cattle and also in mules during the Civil War. His father owned eight hundred acres of land, to which Richard F. Gaines kept adding from time to time, as his financial resources permitted, until he had about three thousand acres in Henry and St. Clair Counties, the extensive tract being devoted to general farming. He was a man of excellent business ability, energetic and far-sighted, and carrying forward to a successful completion whatever he undertook. He lost his first wife in 1868 and was married again to Emily D. Merritt, a daughter of Judge M. B. Merritt of Henry County.
